2. and the property of **SHOCK WAVE SOUND**, if the client or his/her guests caused the damage(s).

By signing this contract, it is to the best of **SHOCK WAVE SOUND'S** knowledge that you, **THE CLIENT**, completely understand the terms in this contract. The **CLIENT** agrees to pay for the total time contracted above. After signing this contract, please mail the white original to **SHOCK WAVE SOUND** along with your deposit so we can hold your date for you.

Cancellation due to inclement weather will result in the forfeiture of your deposit, unless the event is rescheduled before Shock Wave Sound starts playing. After Shock Wave Sound starts playing, the full fee will be due. Cancellation of service within 90 days of your event will result in the total amount of the contract as if services were rendered.

NOTE: This legal and binding contract covers the complete terms of the agreement. Any changes must be mutually agreed to in writing. **PLEASE** do not hesitate to ask or call if you have any questions before signing this contract. There will be a \$30 fee on any returned check.
